

Situse 4: Member and their system of registration.

The person whose age is more than 18 years, any such Indian citizen botain the membership of the society. The person who admit and accept ules and laws of the institute shall have to apply to the secretary with the commendations of any two office bearers in executive body. After the approval to such application by the executive body and after depositing the prescribed amount of membership in the institute the member will be informed in writing and his name will be included in the list of members.

Clause 5: Types of membership

- A) Life member To become life member, the person can become life member after depositing life membership fees Rs.10, 000/- (Rs. Ten Thousand Only) he can become the life member of the institute and he will be the member of the institute till his life.
- B) General member- To become the general member, a person can become a general member after deposit of Rs.5000/- (Rs. Five Thousand Only) as general member fees.

Clause 6: Cancellation of membership

If any member is a convicted criminal, if he has not paid the membership fees, if he has resigned and such resignation is approved by the executive body, upon his death, left the country, if he is addicted or his misbehaving resulting in damages or loss to the institute and if he is not remaining present in the three meeting consecutively after receiving the notice or if the executive body passes such resolution by majority then his membership will assumed to be cancelled.

Clause 7: General Meeting its powers and functions.

General meeting is a combination of life members of the institutes and the general members of the institutes. The annual meeting will be conducted after the completion of financial year of the institute. The powers and functions of general meeting are as under

Clause 10: Arrangement of executive body of the institute and office bearers.

- A) The executive body of the institute will consist minimum 11 and maximum of 15 members.
- B) Every member of the institute is eligible to be elected on executive body.
- C) Following office bearers will be in the executive body of the institute.

 One President, One Vice-President, One Secretary, One Joint Secretary, One Treasurer and other members.

Clause 11: The tenure of executive body and system of election of executive body.

The first executive body shall be of 5 years tenure and thereafter the tenure of executive body elected in general meeting will be of 5 years. The members of executive body of the institute will be elected after every five years in general meeting by secrete voting system or by raising hands, if no election are conducted due to any natural calamity or the epidemic or the pandemic as declared by state govt. central govt. or world health organization, then in such case the old executive committee will look the affairs till further elections.

Clause 12-Office bearers in executive committee and their functions.

A) President -

- Accepting the chairmanship of equal general meeting or the meeting of executive body and conduct the working of such meeting.
- 2) Discussing with consensus on any issue in general meeting for any important work in special general meeting or the meeting of executive hody as presiding officer and will deliver his decision and such decision

shall be final decision.

Aurchase and sale of immovable property with the approval of executive by, to mortgage, donate, take and give the property on lease, to distruct the buildings for institute and to raise building fund for the same, to repair the building, to raise loans on buildings already constructed, to raise loans by mortgaging the immovable properties and to make signatures on any such type of document.

12) If required any person outside of executive body and apart from the members of executive committee will be given the temporary powers for the benefit of the institute and for any educational purpose for the purchase or lease of any immovable property, such powers shall be of temporary in nature and such orders will be issued by the President.

B) Functions of Vice-President

- 1) Looking the work of President in his absence.
- 2) To assist the President in his work.

C) Functions of Secretary

- To look after the all types of communication and correspondence of the institute.
- 2) To maintain all types of registers as per the requirements.
- 3) To write all resolutions and notices of the meetings.
- 4) To verify the accounts of the institute.
- 5) To send the program cards with the consent and signature of the President.
- To assist President and Vice President in their work.

D) Joint Secretary

1) To look after the work of secretary in his absence and help him in the working of the institute.

E) Treasurer

- 1) To keep control on financial transactions.
- 2) To verify the accounts of the institute.
- 3) To get the accounts of the institute audited and to prepare the audit report and to give all information regarding the same to executive body.
- 4) To prepare annual budget of the institute and get it approved.

Clause 17: Powers and duties of Executive body.

A) Collect and raise funds for the completion of object of the institute, to increase such fund, to expand it property, to accept donations and govt., Semi govt. grants.

- B) To rise loans, to accept deposits for the completion of the objects of the institutes in accordance with the concerned provision of Mumbai Public Charitable Trust Act 1950 and Rules there under.
- C) To approve the daily budget of expenditure, to approve the amount therein and to give approval to such expenditure time to time.
- D) Subject to the rules of the society registration Act 1950, construct the buildings and property of the institute, mortgage them, taking and giving the same on rent or on lease basis, use the same for completion of the objects of the institute.
- E) To appoint subject committee, subcommittee for the implementation of the objects of the institute, to decide the number of members thereon, their tenure, area of operation, work system, financial systems etc. To appoint proper and experience experts on such committees from all the members for ex. construction committee, cultural program committee, building fund collection committee, planning and development committee, grievance redressal committee etc.
- F) To work as per the provisions of Mumbai Public Charitable Trust Act 1950 and Society Registration Act 1860 for the completion of objects.

Clause 18: Collection of funds and its use.

- Donations and annual contribution received from members contributions from life members.
- Cash donations from local level for expending it as per the objects the institute.

Clause 22: Bank account and related financial transactions.

Any amount / fund which come to the institute shall be kept in a bank account of any nationalized, cooperative bank in the name of the institute. The bank transactions in this bank account shall be done by the joint signature of any two office bearers from namely President, Secretary or Treasurer.

Clause 23: System of maintaining the list of members.

The list of executive body members and all other members shall be kept and maintained in schedule 1, 2 and 15 as mentioned in Maharashtra society Registration by laws 1971 and rules which shall be informed time to time to the Asst. Register (societies).

Clause 24: Provision to make amendments in Rules and sub rules.

The 3/4 majority shall be required, in special general meeting or in annual general meeting for amending the existing rules and inclusion of new rules. The procedure as per the provisions under section 12 and 12A of Society Registration Act 1860 shall be compiled.

Clause 25: Provision to change the name or object of the institute.

Any change / changes in the name or object of the institute is to be done then procedure under section 12 and 12 A of society Registration Act 1860 will be followed and a 3/4 majority in general meeting shall be required for the same.

Clause 26: Irrevocability

The trustees do hereby expressly declare that the trust is irrevocable and shall continue to exist sine-die. No part of the trust fund/assets in any circumstances whatsoever shall be paid or applied or transferred except for the benefit of the public. The trust shall not be revoked until the term or purposes of the trust have been completed. If the Trust fails or is held to be invalid or becomes uneconomical or unwieldy to administer for any reasons whatsoever, the terms of the trust shall be amended or revised only with the prior/consent of appropriate authority.

Rules and Regulation:-Matsyodari Shikahan Sanstha's, Ambad / Jalna Dist. Jalna

Membership: A)

The person who is 18 year old, must be an Indian, he should pay the contribution that the institution has decided and the direction body should give the approval to his membership than he can be the member of this institution.

If any one wishes to be a member of this institution he must be the Indian above 18 years. He should pay the decided contribution to the institution upon which society considers his member ship, he can be member of the society.

The membership of the institution will be as following.

- 1) Life members -Those who pay Rs. 501 /- at one time to the institution.
- 2) Common membership Those who pay the annual contribution Rs.25.

B) The Cancellation of the membership :-

The membership of member can be cancelled if he is dead if he gives resignation to the president, if he doesn't give the annual contribution in time or late to do so, or the directors body take decision to cancel some body's membership.

If the director body has taken decision to cancel someone's membership, then it is not the responsibility of the institution to give reason for that. If the membership is cancelled because of the Areas 1/2 about the and if he repaid all, then he could be the member of the institution again, but at this time the institution must take the decision.

In case, the institution wants to cancel the membership because of the inconvenience of the contribution, the institution is supposed to inform him before 15 days, and let him opine himself about it. All within 15 days the member must pay their contribution three months before the audit of the institution. All the members will have the equal right to vote.

2) General Meeting: All the members are included in this assembly, all the kinds of property will belong to this common body. The audit years of the institution will be from 1st April to 31st march. After the audit of the institution the meeting will be called before the next year, all the members will be noticed before 15 days. In the notice, the date, time, subject and the place will be mentioned.

2

The corrum will be considered when 1/3 members out of total strength or 25, or the less number whatever if may be will remain, present for the meeting. If the corum is less after half how again the corrum can be called at the same place. This type of meeting would not need the corrum.

Bl If one third members or more than that write to the president to call the meeting. The president will then call the special general meeting. For this special meeting, the rules of general assembly will be considered. If the special general meeting is not called after the written request then the requesting members can call the special general meeting. All the passed resolutions are restricted to the institution and to the life members of the institution. The body members or the directors body can call the special and urgent general meeting for the purpose of the urgent causes.

C) The Functions of General Meeting.

The following activities will be done in the general assembly.

- 1) To give the sanctions to the accounts of the director's body and the audits that assessed by the auditor.
- 2) To approve the budget that is put by the directors body.
- 3) To elect the director's body and life members after every five years.

 The director members will be the life members of the institutions as follows:
- 1) President 2) Voice-President 3) Secretary 4) Asst. Secretary 5) Treasury
- 4) To appoint auditor of the institution.
- 5) All the decisions are taken by the president, they will be considered after the permission of other members only.

One member will give one vote at once. The voting will be open or secret that the president will decide, if the voting is done openly and 2/3 of the members demanded that it should be secret, so the secret voting will be taken at the same time. The absent members can't send their representatives in the meeting. The President will reserve his right to take decision while there is equality in votes.

D) The Directors Body:

a) There will be 11 members in the director's body, The members of the director's body and their officials will be elected after every five years, in general assembly that too in the general meeting. The director's body which was at the time of registration will look after the institution only for five years since registration. If director's body will appoint any of the members it any seat gets vacant, such a candidate will work up to next election.

In the special meeting or general meeting the members can pass a motion of no confidence on the body member or the members of director's body. If the motion will be passed with majority, the new election for the member or the director's body can be arranged, and the members are elected. The director's body which is newly elected will be remained for the period of 5 years.

- 3) The meeting of the directors body will be called at least once in the period of three months. The meeting will be called at any time for the sudden cause as unexpected happenings, otherwise the circulating system can be adopted for the meeting to take decision. the date, the day, the time, the subject and the place will be mentioned in the notice.
- b) The Function of the director's body.

- 1) To implement the decisions taken in the general meeting.
- 2) To look after the daily and common affairs of the institution.
- 3) To make the membership of the institution or to cancel the membership of someone.
- 4) To take loans, to accept donations, to get grant, contribution & to raise funds.
- 5) To keep the accounts of the institutions, make their audits and put them before the general meeting.
- 6) To plan and make the budgets of the institution, and put them for grant before the general meeting.
- 7) To appoint the servants of the institution, to sanction their leaves and to reduce them.
- 8) To maintain all kinds of property of the institution and in change it with the sanction of the general meeting.
- 9) To Spread the branches of the institution or to merge some other relevant institution in the institution, but the merging institution must have the same goals and achievements.
- 10) To make the rules for the internal affairs of the institution to appoint the employees.
- 11) To take necessary decision for the education e. g. to give scholarship, to help for the education, to get loans, to distribute various scholarships to the students.
